

Two different ways to get to the field:

- 1. Hwy 183 exit New Hope Lane, turn right on New Hope, follow it to CR 180, turn left go down CR 180 shortly after the sharp turn to the right, the field will be on the right about ½ mile before you get to the stop light.
- 2. From IH35 North Exit 1431, turn right on Palmer/Ronald Reagan, 1 mile turn left on CR 180, go about 1/2 mile the field is on the left
