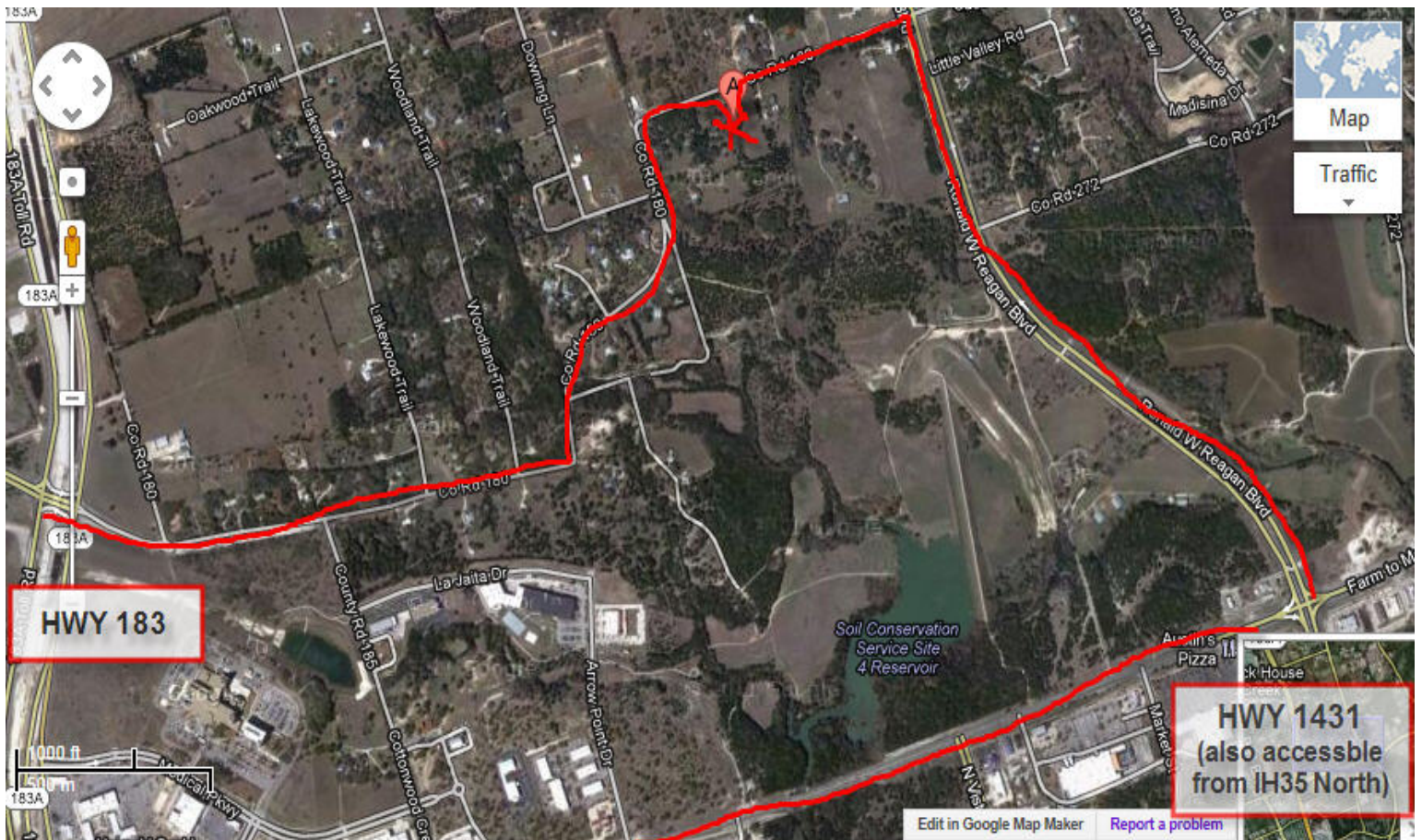

We are showing you three different ways to get to the field:

You can come by way of Hwy 183 exit 1431 go to the intersection of 1431/Palmer turn right on Palmer/Ronald Reagan, 1 mile turn left (it is the first left) and go about 1/2 mile the field is on the left

If you come from IH35 North Exit 1431, turn right on Palmer/Ronald Reagan 1 mile turn left (it is the first left) and go about 1/2 mile the field is on the left

Or you can take Hwy 183 to New Hope Lane, going north and follow it to the address
